Grants and Contracts - TCC as Fiscal Agent

This item requests that the Board approve the receipt of funding for the listed projects.

The following are recommended for approval:

I. RECEIPT, AMENDMENT, EXTENSION OF RESOURCES

Florida Distance Learning Consortium (FDLC)

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing contracted staff for administrative functions for FDLC. This funding is provided by the Florida College Fund Specific Appropriation 101 in the amount of \$21,675, with an indirect cost rate of 8%. The funding period is from 7/1/2011 through 6/30/2012.

Florida Distance Learning Consortium (FDLC)

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing contracted staff for administrative functions for FDLC. This funding is provided by the State University System Specific Appropriation 129 in the amount of \$573,859, with an indirect cost rate of 8%. The funding period is from 7/1/2011 through 6/30/2012.

Florida Community Colleges Activities Association (FCCAA)

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, securing the services of James Blackburn as Executive Director of FCCAA. Mr. Blackburn shall administer and develop the FCCAA program at the state level and render an annual report to the FCCAA Presidents Assembly. The amount of the contract is \$111,902, with an indirect cost rate of 2%. The funding period is from 7/1/2011 through 6/30/2012.

Florida Department of Juvenile Justice – Staff Development & Training TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing contracted staff responsible for the development and maintenance of curricula for basic and in-service training of direct care staff employed by the Florida Department of Juvenile Justice and private providers. The amount of the contract is \$1,261,242.77, with an indirect cost rate of 8%, bringing the overall contract to \$2,535,185.90. The renewal funding period is from 7/1/2011 through 6/30/2012, with one option to renew

Florida Department of Education – Race to the Top (RTTT) Administration TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing personnel and other support to the federal RTTT program. This funding will assist Florida with providing conditions for education innovation and reform. The amount of this funding is \$2,602,586, with an indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012, with a two year renewal option.

Florida Department of Education – Differentiated Accountability Plan (DAP) TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing personnel and other regional support for the implementation of this program, helping struggling schools. This funding will provide the lowest-achieving schools and their feed pattern schools with the necessary tools, resources and support for a successful turnaround. The amount of this funding is \$294,841, with an indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012.

Florida Department of Education - RTTT DAP

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing personnel and other regional support for the enhancement of the DAP Program with funding from the federal RTTT initiative. This funding will assist this program with providing conditions for education innovation and reform in this area of public service. The amount of this funding is \$1,110,177, with an indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012, with a two year renewal option.

Florida Department of Education - RTTT Assessment

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing personnel and other support for the enhancement of the Assessment Program with funding from the federal RTTT initiative. This funding will assist this program with providing administrative support in this area of public service. The amount of this funding is \$438,415, with an indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012, with a two year renewal option.

Florida Department of Education – RTTT Partnership for Assessment of Readiness for College and Careers (PARCC)

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing personnel and other support for the enhancement of the PARCC Program with funding from the federal RTTT initiative. This funding will assist this program with providing administrative support in this area of public service. The amount of this funding is \$420,971, with an indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012, with a two year renewal option.

Florida Department of Education – RTTT Postsecondary Assessment
TCC will serve as fiscal agent to provide personnel and other support for the
enhancement of the Postsecondary Assessment Program with funding from the federal
RTTT initiative. This funding will assist this program with providing administrative
support in this area of public service. The amount of this funding is \$200,218, with an
indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012, with
a two year renewal option.

Florida Department of Education – Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR UP)

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, for the GEAR UP grant from the U.S. Department of Education. This funding will assist in preparing disadvantaged youth to succeed in postsecondary education and providing unparalleled opportunities for improving student success in North Florida. The amount of this award for the fourth year is \$3,234,715, with an indirect cost rate of 8%. The funding period is from 7/15/2011 through 7/14/2012.

Florida Sterling Council

TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing contracted staff responsible for the administrative functions of the Florida Sterling Council's Organizational Performance Excellence Program. The amount of this contract is \$296,296, with an indirect cost rate of 10%. The funding period is from 7/1/2011 through 6/30/2012.

Florida Department of Corrections – Special Education Teacher Aides (SPED) Program TCC will continue to serve as fiscal agent for fiscal year 2011-2012, providing contracted staff to assist in the administration of the SPED program. This program will provide aides to assist special education teachers in providing one-on-one instruction to special education inmates. The amount of this contract is \$688,478.84, with an indirect cost rate of 8%. The funding period is from 8/1/2011 through 7/31/2012.

College Center for Library Automation (CCLA)

TCC will continue to serve as fiscal agent for fiscal year 2011-2012 for CCLA as per the contract between the Florida Department of Education, Division of Florida Colleges, the College Council of Presidents and Tallahassee Community College. CCLA provides the statewide centralized library automation products and services of the Library Information Network for Community Colleges (LINCC) serving the 28 institutions in the Florida Community College System. The amount of this award is \$12,827,107 (9,107,522 for CCLA operations, \$3,669,525 for statewide e-resources and \$50,000 for maintaining the K-12 bibliographic database), with an indirect cost amount of \$100,000. The funding period is from 7/1/2011 through 6/30/2012.

II. COMMITMENTS, EXPENDITURES, CONTRACTS FOR SERVICES

College Center for Library Automation (CCLA) – Avalanche Partnership

Annual contract renewal of lease for CCLA centralized computing facility in Innovation
Park for the period of 7/1/2011 through 6/30/2012. The contract amount is \$578,472.

College Center for Library Automation (CCLA) – Ex Libris USA, Inc.
Renewal of contract for annual software maintenance, development and support costs as part of the legislatively-mandated joint community college and university library system effort. Contract amount is approximately \$950,000 for the period of 7/1/2011 through 6/30/2012.

College Center for Library Automation (CCLA) – Dell Equipment
Contract renewal for the continued use of standardized equipment for the LINCC workstation projects and internal CCLA office automation standardization. Community college statewide contract pricing will be utilized wherever possible in this relationship. [State College of Florida, Manatee-Sarasota; Dell Contract No. 02000014] Contract amount is approximately \$750,000 for the period of 7/1/2011 through 6/30/2012.

College Center for Library Automation (CCLA) - Lyrasis

Renewal of annual membership and on-demand library support and consultative services as needed. The amount of dues is approximately \$190,000.

<u>College Center for Library Automation (CCLA) – Statewide Access to Electronic</u> Resources

Annual contract renewal for electronic library resources purchased cooperatively by CCLA on behalf of the 28 community colleges of Florida through both specific state funding and institutionally contributed funds. Note: Each of the databases, E-books, E-journals, and other E-content is sole source due to copyright restrictions and is only available from the copyright holder or designated provider. The contract period is from 7/1/2011 through 6/30/2012 for these resources. The total for all combined is approximately \$5,200,000.

Salient Facts:

The Board of Trustees has authority to contract with outside agencies for provider management.

Past Actions:

The Board approved the acceptance of the award for the Florida Department of Juvenile Justice in June 2010. In September 2010 the original contract was amended and executed for the additional funding, approved in June 2010, to become a separate contract. The contract requested today is the first of two possible extensions.

Future Actions:

No further activity on the part of the Board is necessary.

Funding/Financial Matters:

The first three projects listed above will be established in Fund 6, Agency Accounts. The indirect earned from these awards will be \$46,307. The remaining projects will be established in Fund 2, Restricted Accounts. The indirect earned from these awards will be \$998,452. Funding for all of the contracts listed above, under Section II will be provided through the College Center for Library Automation.
