Overview and Background

Overview:

I. Receipt, Amendment, Extension of Resources

America Association of Community Colleges – Plus 50 Encore Completion Program

This award will provide opportunities to expand programs and services for adults age 50 and over, leading to the completion of degrees, certificates and not-for-credit credentials in the high-demand fields of healthcare education and social service. The amount of this award is \$15,000, with an indirect cost rate of 0%. The funding period is from 1/1/2013 through 12/31/2015.

Florida A&M University – Florida Georgia Louis Stokes Alliance for Minority Participation (FGLSAMP)

This award will provide services associated with the FGLSAMP NSF Cooperative Agreement to fund students and student organizations with the objective of increasing awareness in STEM disciplines. The amount of this award is \$125,000, with a modified total indirect cost rate of 5%. The funding period is from 10/1/2012 through 09/30/2017.

II. Commitments, Expenditures, Contracts for Services

FDOT Professional Sports Marketing – Daytona International Speedway, LLC

This contractual service agreement will provide advertising and promotional benefits to encourage sobriety and responsible driving during specified events held at the Daytona International Speedway. The contract amount is \$50,000. The contract period is from the date of approval through 9/30/2013.

FDOT Spanish Language Training for DUI Officers – Partners in Training Consultants

This contractual service agreement will provide qualified training instructors to teach Spanish courses to law enforcement officers. The contract amount is \$116,760. The contract period is from 12/17/2012 through 9/30/2013.

FDOT Traffic Records Coordinating Committee (TRCC) – Cambridge Systematics, Inc.
This contractual service agreement will provide logistical and technical advice to the TRCC Executive Board and assist with strategic planning. The contract amount is \$109,927. The contract period is from 11/28/2012 through 9/30/2013.

FDOT Florida Impaired Driving Campaign – Fox Sports Florida/Sun Sports
This contractual service agreement will provide advertising and promotional benefits during specified broadcast through this network to encourage sobriety and responsible driving. The contract amount is \$200,000. The contract period is from the date of approval through 9/30/2013.

FDOT Florida Law Enforcement Liaison Program – Think Creative
This contractual service agreement will provide maintenance and support for webhosting and reporting for the Florida Law Enforcement Liaison Program. The contract amount is \$13,800. The contract period is from 11/27/2012 through 9/30/2013.

FDOT Major College Sports Marketing – Clutch Performance, LLC
This contractual service agreement will provide advertising and promotional benefits to encourage sobriety and responsible driving during college sporting events. The contract amount is \$30,000. The contract period is from 11/5/2012 through 9/30/2013.

FDOT Professional Sports Marketing – Miami HEAT
This contractual service agreement will provide advertising and promotional benefits during the Miami Heat home games to encourage sobriety and responsible driving. The contract amount is \$200,000. The contract period is from 10/17/2012 through 9/30/2013.

FDOT Major College Sports Marketing – Seminole IMG Sports Marketing
This contractual service agreement will provide advertising and promotional benefits to encourage sobriety and responsible driving during specified Florida State University sporting events. The contract amount is \$164,000. The contract period is from 10/10/2012 through 9/30/2013.

FDOT Major College Sports Marketing – University of Florida
This contractual service agreement will provide advertising and promotional benefits to encourage sobriety and responsible driving during specified University of Florida sporting events. The contract amount is \$55,500. The contract period is from 10/10/2012 through 9/30/2013.

FDOT Major College Sports Marketing – Hurricane Sports Properties
This contractual service agreement will provide advertising and promotional benefits to encourage sobriety and responsible driving during specified University of Miami sporting events. The contract amount is \$150,000. The contract period is from 10/10/2012 through 9/30/2013.

Past Actions by the Board

There has been no previous action by the Board on this funding.

Funding/Financial Implications

The above projects will be established in Fund 2, Restricted Accounts. The indirect earned from these awards will be \$1,045.
