## MEMORANDUM

**SUBJECT:** Academic Programs and Course Changes

---

### Item Description

This item presents proposed changes in curriculum for 2013-2014.

A new Associate in Science Degree for paramedics and licensed practical nurses to transition to registered nurses is proposed. All Associate in Applied Science degrees will be deleted in accordance with Florida law and transition plans for students in the degrees are provided. Other course, certificate, and degree deletions in credit workforce programs are presented to update curriculum and assure timely progression through degrees and certificates.

### Overview and Background

The Academic Planning Committee Curriculum members review and make recommendations for Board approval for new programs and courses. Recommendations align with state policy, SACS accreditation standards, and the College's mission. The Committee presents the Board with the attached recommendations. The Board has the responsibility for approval and discontinuance of courses and programs in accordance with Florida state law.

### Past Actions by the Board

The Board approves curriculum changes periodically. These changes will be effective for the 2013-2014 academic year.

### Funding/Financial Implications

These curriculum changes require no new funding.

## **NEW PROGRAMS**

### **AS Degree in LPN/Paramedic to RN**

The program will allow Florida licensed practicing nurses and paramedics to transition into the nursing program and receive 14 credit hours of exemptions. The students will take a 7 credit hour transition course at the beginning of the nursing program to assist with transitioning. This program provides an opportunity for a practicing LPN or Paramedic to build on knowledge previously learned. Graduates of this program will be eligible to site for the licensing exam to become a Registered Nurse.

## **PROGRAM DELETIONS**

AS Degree in Graphic Design Technology, Interactive Media Track is proposed to be deleted because the AS Degree in Graphic Design Technology Graphic Design Track has been combined with Interactive Media Track in order to offer one single degree in Graphic Design Technology. The following certificates associated with the degree will also be deleted:

- Certificate in Interactive Media Production
- Certificate in Interactive Media Support

AS Degree in Biotechnology is proposed to be deleted due to low student enrollment and employability in our three county district is virtually non-existent.

The State Board of Education is requiring that all Applied Associate of Science (AAS) degree no longer be offered as of the 2013-2014 year. The following AAS programs and the associated certificates are proposed to be deleted:

Certificate in Diagnostic Medical Sonography proposed changes are based upon a review of curriculum standards. Changes include moving changing the program name to Certificate in Sonography. In order to enlarge the applicant pool, changes also include the admission criteria: from licensed Radiologic Technologists to include licensed/certified (in Florida) health care practitioners who have AS degrees in clinical practice areas from SACS accredited programs. Total credit hours for program completion have not changed. The program will be offered over five semesters instead of four semesters and the program includes mandated clinical hours.

AS Degree in Recreation Management proposed changes are based on more options for students. The proposed changes include allow students to expand the variety of courses available to choose for an elective. Currently students may choose courses with the prefix PET, PEM, or HUN. The proposed change is to add the option for students to also choose HUN courses because the HUN courses offered also align with the program learning outcomes.

AS Degree in Office Administration proposed changes to delete a course and add an additional elective. The proposed changes are due to program redesign and the course that is being deleted from the program did not align with any of the program learning outcomes. Total credit hours for program completion have not changed.

AS Degree in Computer Programming and Analysis – Computer Game Design and Logic proposed changes to make the degree more flexible as well as to add more graphics classes. The change also includes allowing students to choose a programming course such as COP 2221, COP 2332, or COP 2800. Total program hours are not changing.

Foreign Language waivers for Disability Support Services Students – The legislation will require students to complete two years of foreign language in high school or two semesters in college prior to transferring to the university. Two course substitutions will be used for the foreign language requirements.

OST 1719 – Advanced Word Processing; *Course name change* to Advanced Document Processing and *Course Description change*.

CGS 1030 – Computer Basics; *Course Description change* to include a statement that students who have previously taken CGS 1060, CGS 2100, CTS 1220C, CTS 1230C, CTS 2225C, or CTS 2431C and earned a “C” or better may not take CGS 1030.

CGS 2100 – Microcomputer Applications for Business; *Course Description change* to include statement that the course is primarily designed for students planning to major in business or a related field. Students are expected to have keyboarding skills and prior computer knowledge.

CAP 2023 - Introduction to Game Programming; *Course change* to offer course in Fall semesters only because there is not enough demand to offer every semester.

CAP 2024 – Advanced Game Programming; *Course change* to offer course in Spring semesters only because there is not enough demand to offer every semester. *Course description change* as well.

CGS 1540 – Database Concepts; *Course number change* to CGS 2540 because the learning outcomes warrant a higher number.
