### I. RECEIPT, AMENDMENT, EXTENSION OF RESOURCES

**1) Organization:** FloridaA&M University– FGLSAMP  
(Contract C-1066 – Modification #7)

**Scope of Service:** To continue performing the duties described within the Florida-Georgia Louis Stokes Alliance for Minority Participation Co-Operative Agreement 0217675. Additionally, this funding will be used to facilitate a FGLSAMP Summer Research program that also includes sending selected FGLSAMP scholars to participate in research experiences at Brookhaven National Laboratory during the summer of 2008.

**Effective Date:** 10/1/2007 – 9/30/2008

**Amended Contract Amount:** \$80,663.00 (An increase of \$33,500.00)

**Indirect Rate:** 5%, Modified Total Direct Cost (MTDC), \$262 (This represents the amount for the additional funding only.)

**Scope of Service:** To provide CJSTC approved advanced and specialized training courses through Pat Thomas Law Enforcement Academy for local law enforcement officers  
**Effective Date:** 7/1/08 – 6/30/09  
**Contract Amount:** \$97,580  
**Indirect Rate:** 5%, \$4,646.67
