Amendment #2 - Preferred Customer Electric Service Agreement with

City of Tallahassee

## **Item Description:**

This item requests Board approval for the second amendment to the agreement between the City of Tallahassee and Tallahassee Community College.

#### Overview:

In July 1999 the College entered into an agreement with the City of Tallahassee for a 'Preferred Customer' status for electric service. This agreement was amended in March 2002 to include additional meter locations and to remove some locations no longer in service.

#### Salient Facts:

The agreement allows the College to purchase electric service at a discount of 5% to 7% off the City's Standard Rates. This amendment adds the meter locations on Progress Drive and removes two meters for campus signs. This amendment also places all of the meter locations on one account to insure the applicable rates are applied.
